



Status Conference Research Vessels 2026 | Granting of rights of use

Extended abstract and accompanying material for cruise no.: *

The organizer is entitled, but not obliged, to use the speaker's presentation as well as the accompanying materials provided by the speaker, such as the contribution to the conference proceedings (hereinafter also referred to as "contribution") in whole or in part and without restriction in terms of time, space and content, in particular for the purpose of documentation and sustainable provision of the event as well as for the purposes of press and public relations work across all media itself or through third parties. The granting of rights includes the following rights in particular:

- 1. The electronic/digital online right, i.e. the right to make the contribution accessible to users by means of digital or other storage or data transmission technology, with or without intermediate storage, as often as desired in such a way that they have access to the contribution from a place and at a time individually chosen by them and can view it by means of TV, PC, tablet, e-book reader, cell phone or other devices with or without a wire, e.g. via the Internet, UMTS, cable, cable TV, cable TV or other devices. This includes the right to index the contribution and provide it with search functions and thus make it accessible to users for their own content research as well as the right to use the contribution interactively:
- 2. the electronic/digital offline right, i.e. the right to reproduce and distribute the contribution on all physical electronic/digital including interactive data carriers such as CD, mini-CD, DVD, Blu-Ray disc or e-book reader;
- 3. the print right, i.e. the right to reproduce and distribute the contribution or parts thereof in printed form in all formats and for all publications such as brochures, books, magazines, newspapers and other collective works, including all photomechanical processes and telecopying, without limitation as to the number of copies;
- 4. the right to use for press and public relations work (e.g. also advertising other events) in all types of use and media granted under this agreement, in particular also in social media such as YouTube, Facebook, Instagram, Twitter/X, LinkedIn;
- 5. the right to archive the contribution (alone or together with other contributions) in tangible or intangible form, to include it in collections and/or databases and to make it accessible to third parties (e.g. online services, full-text databases).

The aforementioned rights of use are granted without any limitation on the number of copies that may be requested. The organizer is entitled to edit the contribution within the scope of use, in particular to shorten, supplement or combine it with other contributions (editing right), while respecting the speaker's moral rights. In doing so, the organizer shall respect the intellectual and personal interests of the speaker in his/her contribution. Serious edits that are likely to jeopardize legitimate interests require the consent of the speaker. The rights of use are transferable and sublicensable to third parties (e.g. Project Management Jülich, service providers, press companies, social media).

I hereby declare that my contribution, in particular any third-party materials used or provided by me (e.g. photos, texts, graphics) do not infringe any third-party rights and that I can freely dispose of the rights of use granted to the organizer. In this respect, I fully indemnify the organizer against all third-party claims. *
